pieces fit and some don't until later and it takes time to get to a finished product. Please be patient and work with us. Some things we can take care of and some things we cannot. We get better results when we approach problems in a professional manner and being prepared by reading the booklet.

Brothers and sisters, it looks as though Local 406 has started out to be a great year for 2018 as far as work goes, speaking to the members that have been coming out for various types of training.

I would like to take a moment to thank the instructors for the time they have dedicated toward the training of our apprentices and journeymen.

We have taken a step at the Training Site of enrolling all of the apprentices in the blackboard system offered through our International Training Fund and it seems to be a good tool for education. This will help us all stay on the same page and also allow the students the opportunity to participate when away from class. One issue

that we are running into is the Program is not 100% friendly with cell phones, and in many instances, needs to be assessed from a laptop of some sort. Basically, it is not a mobile app, but some things can be seen via internet on a cell phone. This is just a bump in the road that we will have to overcome.

It seems as though more and more certifications and training credentials are being required to either get employment or remain employed. Please check your credentials and stay on top of them. Also, keep up with your password. I mainly am referring to Nantel when speaking of the password, because we do not have your passwords here at the Training Site. If it is lost, depending on the workload at Entergy, we can help you retrieve your password in somewhere between one hour to three days. We are at the mercy of Entergy when it gets to retrieval of passwords. Also, before coming out for a proctored exam through Nan-

tel, it would be wise to sign in and make sure you can get in before coming out to save yourself some time.

On the equipment issue with GSA, not much is being spoken of anymore, but I have reached out to Ms. Ronita Overton who is our contact through International, and she feels that if anything does take place it will be a slow process. In the meantime, I have done necessary repairs to the RT58C that we do own, serviced it, and had Craig work on getting the required paperwork completed to put it on the NCCCO course. We are also scheduling familiarization times with the equipment in shorter times frames and trying to limit the use of them as much as possible, but still giving members the opportunity to use them. This is the only way that we can stay on top of this older equipment and try to make it last as long as possible for the membership.

Schedule and Curriculum Changes

Brothers and sisters, things have been busy at the Training Site. We have been working toward putting more structure and organization toward the Program. This has involved meetings with the contractors, Delgado, Louisiana Workforce, and the business agents at the district union halls. Thanks to all who have participated and helped out moving forward.

We have been working on a schedule and curriculum change that will take place more than likely in August, 2018. We are also making classes available on the blackboard system so those students that are not able to make class for whatever reason will be able to make up some of the required classroom hours. This is not intended to take the place of coming to class at all, nor will they be able to achieve enough hours to participate in blackboard only, but it will allow them to keep up with the class.

Evaluations have picked up with more individuals showing interest toward joining the union and I am scheduling two days out of the month as an evaluation day only. This gives us the chance to move multiple candidates through here at one time instead of spending 2-3 hours on one person once a week as everyone is on the same page and it seems to move along better.

In February, I also attended a job fair at the Livingston Parish Literacy & Technical College which we did get a few good prospects from their automotive tech classes and one is already a pre-apprentice working for a signatory contractor.

March was the deadline for incoming apprentices for 2018 and at the time of writing this, we had 265 applicants to come in for this year.

The next NCCCO class is scheduled for June 23, so check and see if you are within one year of expiring or not, and if you are interested, give us a call and get an application. We are leaving the classes at 4 for this year as it has been, but I have brought this issue before the Apprenticeship Board and we will possibly drop it to three written

classes per year next year. I am asking to drop the number of NCCCO classes in order to allow more time available for apprentice training and also eliminate the cost that we are incurring because of members choosing to test at CBT rather than the site. Also, in an attempt to save this equipment out here and cut down on damage to course materials, we are limiting familiarization time to one hour per machine here at the site by schedule.

Also with the changes in scheduling and classes, we will be looking for more commitment from the contractors on how many apprentices they will be requiring so we can bring the adequate amount of apprentices in for the upcoming year. Thank you all and stay safe out there.

NLRB charges filed against W.W. Contractors

Local 406 is still working with the NLRB on a Unfair Labor Practice Charge that was filed against W.W. Contractors for breaching the contract and not paying dues and benefits to the Local on behalf of our members working at the Hale Boggs Federal Building. Last month, per a request from the NLRB agent handling the case, some of the employees at W.W. were asked to give a deposition on the facts involving the unfair labor practices alleged against the company. I am also working with an agent from the Wage and Hour Division of the Federal Government on charges that were filed by the Local against W.W. Contractors. I supplied the agent with all the information concerning monies due to the employees by the company. As of April 1, a new contract with the company will be in effect and I will be monitoring closely to see if the company complies with the new raises and contributions that are scheduled to take place. Local 406 has received all monies due to the Training Fund and the Central Pension Fund has it's own lawsuit filed against the company. I am in contact with the Central Pension Fund office and they continue to update me on the progress of their suit against the company. The Central Pension

Fund has collected some monies due on the employees, but the company remains delinquent on the total contributions owed to the Fund.

Last month the affiliates of the Southeast Louisiana Building & Construction Trades Council met with the members at Harrah's Casino New Orleans to begin getting input from the workers in preparation for upcoming economic only contract negotiations with the Company. The workers are due a raise on the first of June and when we set a date for negotiations, I will notify our members at Harrah's New Orleans.

On April 3 and April 4, I made a trip to Memphis, Tennessee with our partners in the casinos in Mississippi and New Orleans, Unite/HERE to commemorate the anniversary of the assassination of Dr. Martin Luther King, Jr. and the 1968 Memphis Sanitation Workers' Strike.

In 1968, the Memphis sanitation workers went on strike against the city of Memphis and this strike went on to become a symbol in the labor movement and the civil rights movement. The 1,300 sanitation workers who participated in the strike were inducted into the U.S. Department of Labor's Labor Hall of Fame. Dr. King went to Memphis to march with the striking workers the night before he was assassinated. The sanitation workers won their strike against the city of Memphis and negotiated a union contract with the city that is still in place today.

Union members from all over the country converged on Memphis for a two-day rally and march that started at the Sanitation Workers Union Hall and ended at the Mason Temple Church of Christ where Dr. King delivered his last speech. I was proud to represent Local 406 at the march in support of our brothers and sisters who paved the way to the benefits of the union that our members and other union members all over the country enjoy.

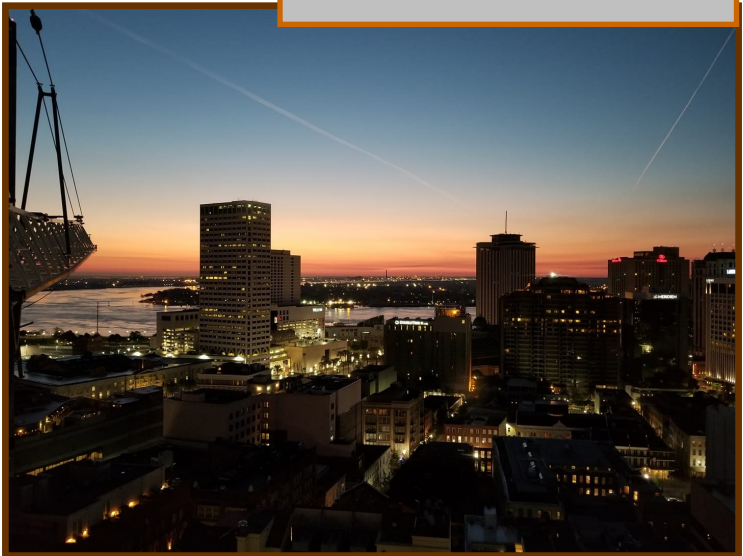

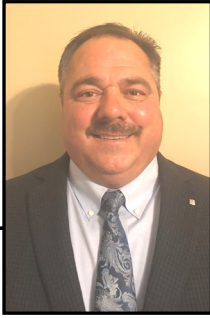
Brother Sal Mangano bird's eye view of tower cranes manned by Local 406 members.

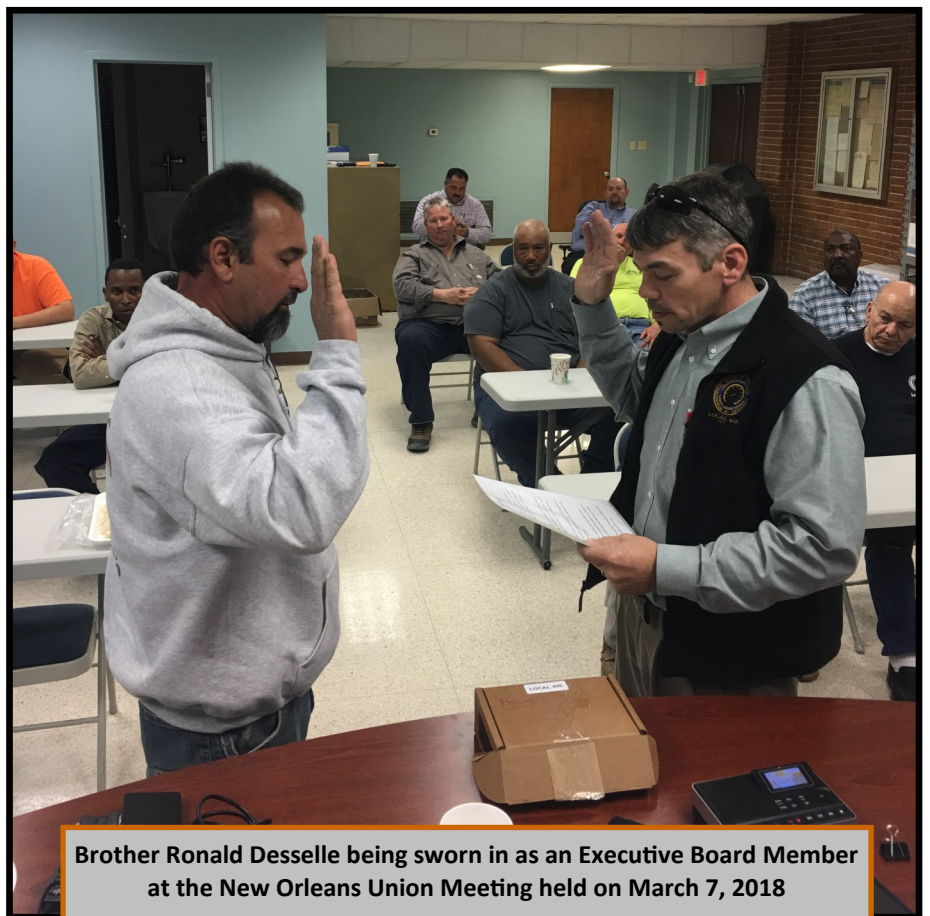

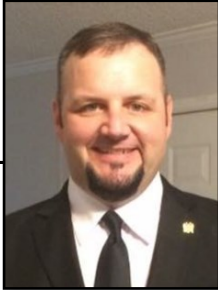

Brother Ronald Desselle being sworn in as an Executive Board Member at the New Orleans Union Meeting held on March 7, 2018

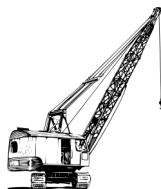
Turnaround work keeping Lake Charles busy

Work in the Lake Charles District has been busy for the first quarter with the yearly turnaround season in full swing. B & G Crane Service started off with their Spring outage at Phillips 66 that took about 20 operators. Turner picking up outages at Sasol, Westlake South and Entergy caused about 15 positions for us to fill with the Crane and Rigging Division. Deep South also had an outage at Westlake South that put about 10 operators to work. There had been some talk about work at Sasol with one of our signatories. They couldn't get the numbers right and finally backed out of the deal with them.

There has been another company that we managed to sign a 5-year agreement with that picked up mechanic work at Sasol and is actively pursuing the same type of work with the other new construction jobs that are coming up in the area. This new company specializes in small to medium duty type mechanic work, anything from golf carts to rough terrain forklifts.



Southern Operators Health Plan Revisions

At the time of this writing, we pretty much have everyone in the Baton Rouge District working.

I would like to take this time to go over some Important Plan Design Changes to the Southern Operators Health Fund effective January 1, 2018.

- First, the Well Child Visits through age 12 is being added to the plan.
- Second, coverage is being added to the plan for necessary Routine Immunizations and Inoculations provided to eligible dependent children through age 12
- Third, Vision Benefits improved from \$200 to \$400 per two consecutive calendar year periods.

These changes can be found in the flyer sent out November 29, 2017 from Southern Operators Health Fund to your home.

During the past couple of months talking to members, seems like they did not know that Southern Operators Health Fund also has a short term Disability Benefit, \$250 maximum period for 13 weeks, first day of accident and eighth day of sickness.

Hoping to see everyone at the Semi-Annual Meeting in New Orleans on Saturday, June 2, 2018.

IN MEMORIAM

Robert H. Boh

Boh Brothers Construction Company

In October last year, Mr. Robert H. Boh, longtime President of Boh Brothers Construction Company, one of our oldest and largest signatory contractors, passed away at the age of 87.

Boh Brothers is one of the largest and most respected general contractors in the Southern United States and is a New Orleans born, family-owned, third-generation heavy construction company specializing in heavy civil construction, piling, marine, utilities, paving and sitework. Robert H. Boh helped build much of New Orleans' infrastructure which employed many of our members, such as the Crescent City Connection, the I-10 High Rise, the Pontchartrain Expressway, West Bank Expressway and the Superdome just to name a few. New Orleans is not the only city that has benefitted from the work of Boh. Baton Rouge also had some major projects which utilized the work of Boh Brothers such as the I-10/I-310 interchange and water-treatment plant for greater Baton Rouge.

Mr. Boh worked with and stayed very involved with our Local for many years serving as Chairman of our Apprenticeship and Training Fund and building a cooperative, respectful and collaborative relationship benefitting the membership, the union and the company. Boh Brothers was also instrumental, along with two of our other signatory contractors, in providing the initial funding for the IUOE Local 406 Welfare Fund back in 2004.

One standout project which employed many of our members was after Hurricane Katrina in 2005, when the I-10 Twin Spans over Lake Pontchartrain connecting New Orleans to the Northshore was completely unusable, closing a vital link from Slidell to New Orleans. The LA DOTD awarded Boh Brothers as the prime contractor for the I-10 Twin Spans Replacement Project (approximately 4.5 miles of low level bridge). Boh Brothers delivered the project ahead of schedule and on-budget with the help of the skilled, dedicated operators from Local 406.

Eligibility

Applicants must be current DRF members at the time the disaster occurred and must reside in the area which has been declared a disaster by the U.S. or State Government or by a majority of the Trustees. A member is eligible for assistance if substantial damage has been incurred from his/her primary residence because of the disaster. The address must coincide with current address on file with Local 406.

Grants

Disaster Relief Grants may be awarded for the purpose of providing cash for temporary emergency expenses for current IUOE Local 406 DRF members approved for relief under the Fund's guidelines.
