## Beau Rivage negotiations almost

**complete** by John Babin Business Rep. Stationary Engineers



At this point in the New Year I have an-

other session of contract negotiations set for the last week of January to continue talks with MGM Beau Rivage for a first Union contract. We have been negotiating with MGM on and off for over a year and I believe we are almost finish getting all the language of the contract agreed on. We should start negotiating economics in the upcoming sessions. MGM is one of the largest gaming companies in the world and they are in great financial shape. The Beau Rivage is a leading profit making property for MGM in the country and our goal is to set the standard for wages in the Gulfport/Biloxi region.

Looking ahead in the market, there are plans for Harrah's Casino New Orleans to build a new hotel attached to the casino downtown. This will mean more construction jobs and permanent stationary engineer positions at the facility. We have one year left on our current agreement with Harrah's New Orleans and with Caesars Entertainment emerging from bankruptcy. I expect better wage increases in our next agreement than we have in the current agreement.

On the organizing front, we are covertly working to sign up workers on authorization cards at the Horseshoe Hotel and

Casino in Tunica, Mississippi. This is also a Caesars-owned property and we hope to get enough cards to convince the company to give us a neutrality agreement. Our partners in the casinos, Unite/HERE, has also organized the IP Casino in Biloxi, Mississippi. They iust ratified their contract last year and I am working to gain contacts in the Maintenance Department at the IP to gage any interest the maintenance workers may have in forming a union with the Operating Engineers.

At the Hale Boggs Federal Complex, I have engaged W.W. Contractors in contract negotiations for a new agreement. The current agreement expired in October, 2017 and I sent a first proposal to the company before the end of last November. I am attempting to schedule a meeting before the end of January to meet with the company's CEO, Timothy Milby, to hopefully get a company response. Local 406 continues to have a Unfair Labor Practice charge filed against W.W. Contractors due to unpaid dues and benefit contributions owed from last year. The company's payroll attorney is slowly, but surely, working with us to resolve the issues. As soon as something breaks, I will notify the members who work for W. W. Contractors.

Local 406 also conducted Universal Freon Certification Training for five members at Harrah's Gulf Coast in Biloxi. As a result of this training, two new members signed up and both were promoted. Any member interested in getting this certification, please call me at the New Orleans office.

The Loews Hotel in New Orleans is looking for a 2<sup>nd</sup> Class Engineer and a Kitchen/ Laundry Mechanic. If any of our members know of someone who is interested in any of these positions, please have them contact me at the New Orleans office.



## New Orleans in a building boom

Happy New Year to all members of Local

406 and their families as well. Now that 2017 is behind us and I'm glad some things are behind us, we begin the new year with a positive outlook. Crane rental agreements are negotiated and signed. Turnarounds, for the first time, will begin a little later this year in the New Orleans area. starting in March, with B & G in Chalmette and Turner at Marathon in Garyville. At the time of this writing, I don't have any details to put down other than word of mouth, but we are pretty sure it will happen. Keep in touch for any new information that comes out or if you hear anything, please give me a call. I would appreciate it.

In New Orleans, we have been successful negotiating, signing and manning two tower cranes for MEGO Construction and Core Construction, and we just recently signed a project agreement with Citadel Builders that will erect two tower cranes on the same job site. The great thing about this is that we are building great relationships with the owners and supervision of these companies and there are more projects on the horizon to be built. Currently, New Orleans is in a building boom building high rise buildings which means work for our members and the down side is that we are running out of certified tower crane operators. With these great relationships, great things are happening. These companies are allowing the operators who are stepping up with a

certification for tower cranes to go on these job sites to get seat time, which is rare. If you kept up with my articles in the past, you read about these opportunities. This is not an apprenticeship school for the unskilled crane operator, this is for members who have been running cranes for some time. Remember that fellows, the main reason for doing this is we need backup operators in case someone gets sick or can't make it to work and it's also for the future work force that will be needed to man these cranes when they are erected. So again I ask for your help in keeping the work we have captured in this City. Remember a contract isn't worth the paper it's written on if you can't man those cranes with good operators.

I will leave it at that, so please keep in touch. Let me know when you are available for work and I will keep you informed about future work in my area. The future look bright. I hope the new year serves you well and I want to be a part of it. Be safe and God Bless. Page 5

On December 18, we went through an audit for the training site by the Louisiana Workforce Commission and all went good with the exception of needing more documentation on class days such as actual written tests. This is an area that I will be showing more attention to. I am looking at options with using the International's Blackboard system during class days and this will also allow apprentices to work on make-up work online and keep all of the eggs in one basket. We will also be sending out letters for apprentices that are not attending the classes and working on progressions as well.

The last quarter was filled with a lot of job fairs as usual. We attended Bonnabel High School, South Central Louisiana Technical College, Grace King High School, Delgado Community College and Deep South Lift and Move Event. Hopefully our efforts will continue to pick up interested applicants for the apprenticeship's 2018 class.

In October, the NCCCO written schedule was updated on our webpage and also included in this newsletter are the four written class schedules for this year. I do plan on bringing an issue before the Apprenticeship Board at our next meeting of possibly removina the last quarter NCCCO as we took a \$300 fine on the last one of 2017 because we did not have enough candidates testing. The last quarter test is one that is always very hard to fill up as members are either working on turnarounds, hunting, fishing, football or traveling for the holidays. It is not discontinued at this time and will remain in place for 2018 and

may never be discontinued as we have always tried to hold true to the promise of one every quarter. I just wanted to mention that it is an issue that many continue costing us in the future.

With the work possibly picking up sometime soon, please remember to check your credentials and assure that they are current and will carry you through your job durations. We mostly think of our Safety Council Cards and TWIC cards, but also keep in mind Respirator Fit Test Cards, DOT Physicals, Security Passport, New Orleans City License for dirt equipment, Block or Unit Orientations, and any equipment specific cards that you may have. I wish everyone a great and prosperous new year.

## HEALTH & WELFARE REPORT

As we start the

new year, I just



wanted to remind those of you who still have a balance in your Health Reimbursement Arrangement (HRA) account that the deadline for filing claims is November 30, 2018. This means that all claims must be received by that date.

As a further reminder, all expenses must be filed under your HRA within 12 months of the date the charge was incurred. By the time you read this, it will be too late to submit expenses from 2016.

To clarify what is required to file a claim, a claim form is required for each family member whom you are filing a claim on. But only ONE claim form is necessary per person per submission, regardless how many different expenses are being filed. You can obtain a claim form by calling the Baton Rouge office at (225) 924-1311 or by printing from website one our at www.406wf.org.

To file doctor and hospital expenses, you must send a copy of the Explanation of Benefits (EOB) from Southern Operators Health Fund (SOHF). You DO NOT need to send copies of actual doctor or hospital bills.

To file Prescription Drug expenses, obtain a print-out from your pharmacy. This provides us with all the information we need to process the expense. Please do not send cash register or any other type of receipts. Because of their small size, these can get lost.

To file dental expenses, you do have dental coverage with Southern Operators Health Fund (SOHF), therefore, as with doctor and hospital expenses, you must send a copy of the Explanation of Benefits (EOB) from SOHF.

Likewise for Vision expenses, you do have vision coverage for eye exams, eye glasses and contacts with SOHF, and so, you must send a copy of the Explanation of Benefits (EOB) from SOHF.

Please note that some of you have sent EOBs from SOHF in which SOHF did not pay the expense, but rather requested additional information. Please read these EOBs and other communications carefully and provide SOHF with the requested information. These expenses will not be covered under your HRA until SOHF actually processes the expense. Once you provide SOHF with the reguested information, they will process the expense and issue another EOB, which you may then file under your HRA.

Finally, on the EOBs from SOHF, the second to last column is titled "Total Patient Cost." If the If the Total of this column is zero, then there is nothing to file under your HRA and you need not submit this EOB.
