As 2022 ended, all our Casino, Hotel, and Sports Arena contracts are in place and running full speed ahead. Our members at Harrah's Casino New Orleans will be getting a wage increase in January and are on the third year of their five-year agreement. Harrah's New Orleans is also looking for 1st and 2nd Class Boiler and Air Conditioning Engineers. Any members who know some engineers looking for work should tell them to contact me at the Union office

Gold Strike Tunica's new Contract that went into place last summer is in place for three years although MGM announced that they will be selling the property to one of the Indian nations. The contract will remain in place under the new ownership, and I look forward to working with the new owners of the property. 2022 RECAP

In the last guarter we had two great representatives of the Union retire, Carlos Benoit and Mrs. Cheryl Frught. It has been a pleasure to work with both and they will both be missed dearly. The even better news is that they made it and I hope they enjoy their retirements with their families and loved ones.

During the months of Oct. & Nov. we attended three career days. The first one was a first for Doyle High School in Livingston Louisiana. The second was hosted by the Baton Rouge Carpenters and Millwrights and the third was at Ponchatoula High School. In addition to those two we have signed a partnership with WhereWeGo that cost \$492 a year. WhereWeGo covers the New Orleans Metropolitan area and will help us in covering our outreach activities for that area along with sharing our information. We have also created our own Facebook Page IUOE Local 406 Apprenticeship Program Heavy Equipment Operators, that we will post before we go to the career days so the membership can send any interested applicants to the events in their respective areas. Also, if there are any interested applicants out there or pre apprentices working PLEASE have them call 985-542-4322 and make sure they are enrolled for the 2023 year. March 31st, 2023, will be the last day that applications will be accepted for the 2023 incoming class. Applicants will have to bring the following on May 24th, 2023

- 1. Louisiana Driver's License
- 2. Social Security Card
- 3. Birth Certificate

4. High School diploma or equivalent

5. Negative drug screen from a medical facility with negative test results (Control and Custody forms from employers cannot be accepted as they do not show results)

After application day there will be two more days that the apprentices will have to attend to be accepted and enrolled in the apprenticeship; Interview Day which will be on June 01, 2023, and Indenture Day which will be on <u>June 22, 2023</u>.

In October / November we also sent three pieces of equipment to Henderson Auction a down cab picker, a bobcat that we used most of the parts off and 2 Link Belt cranes that were left from the government GSA program.

The big elephant in the room are the changes coming from NCCCO. As we move forward a lot will change. We are going to make it but, it will take getting accustomed to. Everything that I am reporting on now will be in reference to the mobile but, I foresee the same following suit with Rigger 1, Signalperson, and Telehandler. Moving forward to achieve the goal of not administering practical exams to candidates that you have previously trained the practical will need to be taken before the written. This option has always been there, it is just a change from how we have done it in the past. Written test moving forward will all be done on computer with no scratch paper at all (we may squeeze one more written in during March, if we can fit it in). At the end of October, we started planning how we would accomplish this. Plans are still in the works, but it is leaning more towards totally enclosed / soundproof cubicles with audio and video monitoring in them. There will be a proctor on the computer that will aid in the testing session. This same test will be able to be done from your home in the future, but you must be mindful of how the requirements will be met for the test session. Issues can be resolved as far as a dog barking, a cat jumping in the window and moving curtains, UPS man ringing doorbell, kids having friends over etc. There is also further training upcoming for us as administrators, administrator assistants, proctors and assistant proctors. We hosted our last written test at the site on 10/29/2022 and the

next one is planned for March 18, 2023, provided we can have everything in order by that time. Lastly, we are feeling like we will need to host Saturday. classes three before scheduling someone for a test. The test will be then done during the week, one candidate at a time until we see the need to add more computers. With those changes. the following are also:

New year already? It seems as 2022 just got started and here


